Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing, wearing a mask when in close contact with others and have, in many locations, prohibited the congregation of groups of people.

Christian Homes Educating Children (CHEC) has put in place preventative measures to reduce the spread of COVID-19; however, CHEC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the CHEC activities could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending CHEC activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at CHEC may result from the actions, omissions, or negligence of myself and other.
